This booklet contains important information to help you make your benefit plan selections for the upcoming plan year, beginning October 1, 2014.

Open enrollment begins August 15 and runs through September 15, 2014, for most participating entities. However, **you should check with your employer to verify when your specific enrollment period ends.** All benefit changes during this period will be effective October 1, 2014, unless evidence of insurability is required for your Optional Life or Long Term Care enrollments.

Plan Choices for Your Employee Group

The OEBB Board does not limit the number of medical, dental and vision plans that can be available to each employee to consider during the open enrollment period. However, OEBB does allow employers and employee insurance committees to choose not to offer all the available options. The coverages available to you through Unum are:

- Employee Long Term Care (Voluntary-Employee Paid)
- Spouse/Partner Long Term Care (Voluntary-Employee Paid)

Also, your employer has elected to provide you with the following Employee Assistance Program (EAP) benefits through Reliant Behavioral Health (RBH):

- EAP - 1 to 3 Visit Model

Enrolling in Benefits, Adding or Removing Dependents, and/or changing your Benefit Selections

To enroll in benefit plans, add or remove dependents, or to change any of your benefit plan selections, you will need to access the MyOEBB Member Module. If you are a first-time user, you'll need to set up an account, or register. If you are a returning MyOEBB user, you will need to log in using the user name and password you created when you initially registered in MyOEBB. If you are enrolling in OEBB benefits for the first time, please remember that you must enroll in each benefit type (medical, dental and/or vision) to receive coverage for that type of benefit. Enrolling in medical only will not enroll you in any other plans, such as dental or vision. You must also enroll each eligible dependent, including your spouse/domestic partner, in each plan for those individuals to have coverage.


